I, the undersigned parent/person having legal custody/guardianship of the above said minor, give permission for the minor to participate in the Trumbull SWCD Watershed Field School 2 day camp on June 17 and 18, 2014. The minor is physically able and mentally prepared to participate in all activities as described in the announcement for the program. **It should be noted that the children will be driven to various sites in the watershed for activities and learning opportunities.**

In consideration of said minor being permitted to participate in this program for observation, use of facilities and equipment, or take part in program activities, I, on behalf of myself (as parent/guardian) hereby:

1. Acknowledge that (i) I have read this document, (ii) I understand locations and activities involved in the program, (iii) I accept them as being safe and reasonably suited for the purposes intended, and (iv) I voluntarily sign this document.
2. Release Trumbull Soil and Water Conservation District (Trumbull SWCD, as overseeing organization), its supervisors, officers, employees and volunteers (collectively "Releases") from all liability to me for any loss or damage to property or injury or death to person, whether caused by Released or otherwise and while such minor is participation in said problem.
3. I agree not to sue Releases for any loss, damage, injury or death described above and I will indemnify and hold harmless Releases and each of them from any loss, liability, damage or cost they may incur due to said minor's presence in, upon, or near Trumbull SWCD facilities, whether caused by the negligence of Releases.
4. I assume full responsibility for, and risk of, bodily injury, death or property damage due to the negligence of Releases or otherwise.
5. I do hereby authorize Trumbull SWCD as agent for the undersigned, to consent with respect to said minor, to any x-ray examination, anesthetic, medical, dental, or surgical diagnosis or treatment, and hospital care which is deemed advisable by, and is to rendered under general or special supervision of, any physician and surgeon licensed in the State of Ohio on the medical staff of any hospital, whether such diagnosis or treatment is rendered at the office of the physician or at the hospital. I understand that Trumbull SWCD is not responsible for costs incurred for medical treatment.
6. Trumbull SWCD and program affiliations may use my child's photos for promotional purposes. I intend this document to be as broad and inclusive as is permitted by the laws of the State of Ohio; if any portion hereof is held invalid, I agree the balance shall continue in full and effect.
